Every Regional Synod was invited to send a delegate.</p> <p>1.2.3 The final Report was compiled on 8 December 2017.</p> <p><b>1.3 Logistical</b></p> <p>1.3.1 174 documents have been sent for the Agenda, consisting of 148 Reports, 12 Petitions of Protest and 14 Points of Description.</p> <p>1.3.2 The Synod will have 70 hours available for its meeting.</p> <p>1.3.3 The hostel, “Dennepark”, must be vacated on Friday, 19 January 2018, by 08:00.</p> <p>1.3.4 The costs of this Synod is ±R450.00 per delegate per day (cost of administration and traveling excluded).</p> <p>1.3.5 The Synod aims to close on Thursday, 18 January 2018, at 20:00.</p> <p><b>1.4 Planning</b></p> <p>1.4.1 Each meeting shall determine its own approach. Synod 2012 primarily followed the approach of finalizing</p>

Where it was necessary, some matters were referred to a Commission.</p> <p>1.4.2 The Agenda was electronically distributed to all churches in August 2017. By then it was already necessary that churches supplied names of elders available for the General Synod to the Regional Synods. Therefore the accompanying letter requested that the Agenda should be made available to the elders.</p> <p>1.4.3 In the second week of December the Supplementary Agenda was distributed electronically to all delegates whose e-mail addresses were available. This approach has made available more time for preparation.</p> <p><b>1.5 Right to speak and turn to speak</b></p> <p>1.5.1 According to the credentials the right to speak belongs to delegates and according to CO, art 18, to professors as advisors.</p> <p>1.5.2 Non delegates who are involved in Reports, Points of Description and Petitions of Protest, will be given turns to speak regarding elucidation.</p> <p>1.5.3 Other non delegates are not granted turns to speak. <b>Motivation:</b> The Synod is an assembly of Regional Synods (CO, art 50), to which delegates are sent by the Regional Synods.</p> <p>1.5.4 Turns to speak must be used economically. <b>Motivation:</b> The Synod is a church meeting (CO, art 30) and not a club for debate.</p> <p><b>1.6 Appointment of Commissions</b> The following criteria is used:</p> <p>1.6.1 Giftedness</p> <p>1.6.2 Choice of delegates</p> <p>1.6.3 Recommendations by Regional Synods</p> <p>1.6.4 Petitions of Protest by which the Regional Synod may be a stakeholder, delegates of those Regional synods will not be part of a Commission dealing with that respective issue.</p>

Delegates are requested not to change rooms allocated to them.</p> <p>2.2 <i>Time table</i></p> <p>2.2.1 The time table is to change from the time table recommended by the Calling Church Council to be compatible with the time table for meals given by Dennepark: 07:00 – 08:00 (breakfast).</p> <p>2.2.2 For Saturday we recommend that the time of the meeting ends at 12:15.</p> <p>2.2.3 On Monday, 15-01-2018 the Synod will commence at 09:00.s</p> <p>2.3 <i>Methodology</i></p> <p>2.3.1 Every admissible matter is tabled, dealt with and a resolution taken (CO, art 30).</p> <p>2.3.2 Petitions of Protest are referred to Commissions for advice.</p> <p>2.3.3 When delivering a Report or putting forward a Point of Description or Petition of Protest, the elucidator does not read the document or present a summary (the delegates have already read it). When really necessary a point can be explained.</p> <p>2.3.4 When the Synod experience difficulties in formulating a resolution, it is then referred to a Commission (Acta 1976, art 12).</p> <p>2.3.5 Commissions that are to be of service for this Synod: Commission of Order, Financial, Appointment of Deputies and Petition of Protest Commission. The other Commissions that are listed below are available for the Synod if necessary.</p>
