Free Church of Scotland (FCS) Ekumeniese eenheid</p> <p>1.1 <i>Opdrag</i></p> <p>1.1.1 Dat die GKSA sy ekumeniese eenheid met die FCS herbevestig.</p> <p>1.1.2 Dat hierdie eenheid onderhou en verder uitgebou word deur besoeke van Deputate en praktiese same-werking waar die geleentheid daar-voor homself voordoen.</p> <p>1.1.3 Dat die opdrag om die betekenis van “kerklike eenheid” verder te bespreek om tot ‘n vergelyk te kom, kontinueer.</p> <p><u>Vir kennisname</u></p> <p>1.2 <i>Uitvoering van opdrag</i></p> <p>1.2.1 Ds TF Dreyer kon tydens die FCS Sinodes van 2015 en 2017 met hierdie kerkverband kontak maak en groetboodskappe namens die GKSA oordra.</p> <p>1.2.2 Gesprekke met die Voorsitter van hulle Deputate vir Ekumeniese Sake, Rev David Meredith, kon by beide hierdie geleenthede gevoer word veral rondom die betekenis van “kerklike eenheid”. Alhoewel hulle ons beskou as een van die kerke met wie hulle Ekumeniese eenheid (Ecclesias-tical Fellowship/Fraternal relations in hulle beskrywing daarvan) het, is die wedersydse beroeping van predi-kante iets wat hulle nie hierby insluit nie. Hulle is egter besig met herbesinning oor hierdie praktyk. Hulle herbesin ook oor hulle praktyk of afgevaardigdes van die kerke met wie hulle eenheid het op beter maniere by hulle Sinodes te betrek as net ‘n kort spreekbeurt om inligting oor te dra. Free Church of Scotland (FCS) Ecumenical unity</p> <p>1.1 <i>Mandate</i></p> <p>1.1.1 The GKSA is to reconfirm its ecumenical unity with the FCS.</p> <p>1.1.2 This unity is to be maintained and promoted by means of visits by Deputies and practical cooperation whenever the opportunity presents itself.</p> <p>1.1.3 The discussion on the meaning of “church unity” is to continue to reach consensus.</p> <p><u>To be noted</u></p> <p>1.2 <i>Execution of mandate</i></p> <p>1.2.1 Rev TF Dreyer was able to contact this denomination during the FCS Synods of 2015 and 2017 at which he conveyed the GKSA’s greetings.</p> <p>1.2.2 Discussions with the Chair of their Deputies for Ecumenical Affairs, Rev David Meredith, were possible at both these events, especially in regard to the meaning of “church unity”. Although they consider us one of the churches with which they have ecumenical unity (their term ecclesiastical fellowship/ fraternal relations), the mutual calling of ministers does not form part of such unity. They are, however, at present reconsidering this aspect. They are also investigating the greater partici-pation, than merely a brief speaking turn to convey information) of delegates from churches with which they have unity at their Synods. It was brought to their attention that it has been quite some time since one of their delegates has attended our Synods and they undertook to send a representative to the 2018 Synod.</p> <p>1.2.3 Since we have a great deal in common</p>

They did, however, mention that they would like to know more about our practice of making churches with which we have unity part of the talks during a Synod, rather than just conveying greetings. Ds TF Dreyer kon tydens sy besoek aan Londen in 2017 opnuut met Rev Paul Levy van hierdie kerkverband en ds HK de Kock gesprekke voer.</p> <p>3.2.2 Ons is opreg dankbaar vir die Gereformeerde getuigenis wat hierdie kerkverband in Engeland, waar hierdie getuigenis skaars is, uitdra. Daar is ook groei wat die Here gee op hulle arbeid.</p> <p>3.2.3 Ons is opreg dankbaar vir die ondersteuning wat hierdie kerkverband gee aan Canada Water Church al is hulle nie formeel deel van die kerkverband nie.</p> <p>3.2.4 Die GKSA het kerkregtelike voorbehoude ten opsigte van die gebrek in onderskeid tussen die dienste van regeer- en leerouderlinge en die sterk Presbiteriaanse kerkregeringstelsel teenoor ons Gereformeerde of Presbiteriale kerkregeringstelsel. Uit gesprekke is dit duidelik dat daar ten opsigte van beide aspekte 'n beweging nader aan ons beskouing by hulle plaasgevind het en dat hulle in lyn is met kerke soos die FCS en FCS(c), sowel die Presbyterian Church of America (PCA) met wie ons reeds eenheidsbande het.</p> <p>3.2.5 Hierdie kerkverband bly na ons mening die beste opsie vir 'n tuiste vir Canada Water Kerk en ds HK de Kock.</p> <p>3.2.6 In die lig van die verwickelinge het ons die Deputate van die IPC uitgenooi om die Sinode van 2018 by te woon met die oog op finale gesprekke rondom ekumeniese eenheid.</p> <p><u>Vir besluitneming</u></p> <p>3.3 <i>Aanbevelings (Opdragte aan te</i></p>	<p>3.1.3 The Synod is to take note of the Deputies' caution around certain canonical aspects and instruct the Deputies to hold further talks with the IPC in this regard.</p> <p><u>To be noted</u></p> <p>3.2 <i>Execution of mandate</i></p> <p>3.2.1 Dr PJ Buys contacted the Moderator of the IPC during his term as Chair of the World Reformed Fellowship (WRF). Rev TF Dreyer was able to once again hold talks with Rev Paul Levy of this denomination and Rev HK de Kock during his visit to London in 2017.</p> <p>3.2.2 We are sincerely grateful for the Reformed testimony of this denomination in England, where such testimony is rare. The Lord has also enabled growth in their labours.</p> <p>3.2.3 We are sincerely grateful for the support this denomination provides to Canada Water Church, though they are not formally part of this denomination.</p> <p>3.2.4 The GKSA has canonical reservations about the lack of distinction between the services of governing and teaching elders and the strong presbyterian church governance system as opposed to our reformed or presbyterial church governing system. Talks clearly showed a move closer to our belief in regard to both aspects and that they are in line with churches like the FCS and FCS(c) as well as the Presbyterian Church of America (PCA), with which we already have unity ties.</p> <p>3.2.5 We consider this denomination to be the best home for Canada Water and Rev de Kock.</p> <p>3.2.6 In light of these developments we invited the Deputies of the IPC to attend the Synod of 2017 for final talks on ecumenical unity.</p> <p><u>To be decided</u></p> <p>3.3 <i>Recommendations (instructions to the</i></p>

Daar is voortdurende groei in getalle, maar ook baie duidelike geestelike groei wat waarneembaar is in die jongmense (tussen die ouderdom van 25 en 35 jaar, wat 75% van die gemeente uitmaak) se bereidheid om te dien. Nog 'n groeipunt is hulle getuienis in die gemeenskap en die positiewe rapport wat hulle in die Canada Water gemeenskap het. Dis 'n baie sentrale en sigbare bymekaar-</p>	<p><i>next Deputies)</i></p> <p>3.3.1 Note is to be taken with gratitude of the existing ecumenical ties between the GKSA and IPC.</p> <p>3.3.2 These ties are to be maintained and strengthened, by means of <i>inter alia</i> mutual visits of Deputies and cooperation at practical level.</p> <p>4. London Ministry Ecumenical Unity</p> <p>4.1 <i>Mandate</i></p> <p>4.1.1 The Synod is to take note with gratitude of the continued ministry among South Africans as well as among the community in which these churches reside.</p> <p>4.1.2 The Synod is to again approve one collection per year for the support of this ministry in London and that the Deputies, in collaboration with GK Randburg, ensure that these funds are best applied to that ministry.</p> <p>4.1.3 The Deputies are, in cooperation with GK Randburg, to take an advisory role in the further development of the ministry in London, especially in terms of the possible joining with the IPC.</p> <p><u>To be noted</u></p> <p>4.2 <i>Execution of mandate</i></p> <p>4.2.1 Rev TF Dreyer visited Rev HK de Kock and the church in London (Canada Water Church - CWC) in 2015 and in 2017.</p> <p>4.2.2 We report with gratitude that all is well with the congregation. Growth in numbers is continuous, but spiritual growth is also clearly observable in the willingness of the youth (between the ages of 25 and 35 that make up 75% of the congregation) to serve. Further evidence of growth is their testimony in the community and the positive rapport they have in the Canada Water community. They gather at present in the auditorium of the new library, right at the Canada Water tube station. It is a hugely central and visible gathering complex helping them to reach people and become known in the community.</p>

<p>komplek wat hulle help om mense te bereik en bekend te raak in die gemeenskap.</p> <p>4.2.3 Die getal Suid-Afrikaners in Engeland en spesifiek in Londen het soos voorspel, baie afgeneem. 'n Beduidende deel van die gemeente is egter steeds Suid-Afrikaners (byna 20% van die lidmate). Die omstandighede in Suid-Afrika sorg voortdurend vir jongmense wat groener weivelde in Engeland en spesifiek Londen gaan soek, alhoewel dit nie meer so gereeld soos in die verlede is nie. CWC kry ook gereeld Suid-Afrikaners wat vir kontrakwerk (6 maande tot 2 jaar) na Londen kom en dan by hulle inskakel. Daar is ook 'n toenemende getal tweede generasie Suid-Afrikaners wat aanklank vind by die gemeente wanneer hulle in Londen kom studeer. Canada Water is 'n omgewing in sentraal Londen wat 'n hele aantal tersiêre instellings huisves en wat geormerk is vir geweldige verdere ontwikkeling. Daar word tans beoog om die populasie hier te verdubbel deur 'n hele paar wolkekrabbers op te rig.</p> <p>4.2.4 Die voorsienigheid van die Here is duidelik sigbaar in die area waarin Canada Water Church haarself bevind. Ds de Kock sal tydens die Sinode meer inligting hieroor gee.</p> <p>4.2.5 Die gemiddelde bywoning van 'n Sondagoggend-erediens is in die omgewing van 100-120 mense wat die gemiddelde erediensbywoning in Engeland met 60-80 mense oorskry.</p> <p>4.2.6 Ons is ook dankbaar oor die duidelike trajek van groei ten opsigte van inkomste waarop die gemeente is. Die gemiddelde koste van hierdie bediening vir GK Randburg het gedaal van R160 000 per jaar tot R120 000 per jaar. Daar word dus nie enigsins meer oorbetalings gemaak vanuit Suid-Afrika vir hierdie bediening nie. Al koste wat oorbly is basies ds de Kock se pensioen-bydrae en 'n klein behuisingstoelaag. As alles volgens plan verloop sal dit binne die volgende 3 jaar deur die gemeente in Londen gedra kan word.</p>	<p>4.2.3 The number of South Africans in England and specifically in London has declined significantly, as predicted, but a significant part of the congregation remains South African (almost 20% of membership). Conditions in South Africa ensure a continuous flow of young people seeking greener pastures in England and specifically London, although not quite as much as in the past. CWC also has a regular influx of South Africans coming to London on contract work (6 months to 2 years). CWC also attracts an increased number of second-generation South Africans completing studies in London. CWC is located in central London with a number of tertiary institutions and is earmarked for significant further development. The intent is to double the population by erected quite a few skyscrapers.</p> <p>4.2.4 The providence of the Lord can clearly be seen in the area where CWC is located. Rev de Kock will provide further information in this regard during the Synod.</p> <p>4.2.5 The average attendance of a Sunday morning service is about 100-120 people that exceeds the average church attendance in England with 60-80 people.</p> <p>4.2.6 We are also grateful for the clear trajectory of growth in terms of income of the congregation. The average cost of this ministry for the GK Randburg has reduced from R160 000 per annum to R120 000 per annum. No additional transfers are, therefore, made from South Africa for this ministry. The only costs that remain are Rev de Kock's pension contribution and a small housing allowance. If all goes to plan, the congregation in London will be able to shoulder this within the next 3 years.</p>

<p>4.2.7 Ons enigste besorgdheid bly die inskakeling van die gemeente by 'n plaaslike kerkverband vir genoegsame verantwoordbaarheid. Die jeugdigheid van die gemeente tesame met die feit dat mense hulleself nie normaalweg vir 'n lang tyd in sentraal Londen vestig nie, maak dit veral moeilik om ouderlinge te kry wat vir 'n voldoende tyd kan dien. In hierdie opsig het Canada Water-kerk dieselfde uitdaging as 'n studente gemeente. GK Randburg se toesig was tot op hede belangrik maar dit bly 'n uitdaging om van so 'n afstand af sinvol betrokke te wees. Pogings om die gemeente sinvol by Klassis Johannesburg in te skakel was ook onsuksesvol. In die lig van die positiewe ontwikkelinge in ons verhouding met die IPC is ons van mening dat dit die beste opsie bly vir die gemeente om deel te word van hierdie kerkverband.</p>	<p>4.2.7 Our only concern is the congregation collaborating with a local denomination to enable adequate accountability. The youthfulness of the congregation together with the fact that people don't usually remain in central London for long makes it especially difficult to find elders who can serve for an adequate period of time. It is the same challenge a student congregation would face. The supervision of GK Randburg has been important to date, but its rather challenging to be involved at such a distance. Attempts to link the congregation with Classis Johannesburg was also unsuccessful. In light of the positive developments in our relationship with the IPC, we are of the opinion that the best option would be for CWC to become part of this denomination.</p>
