The unity of the church as mystic body of Christ is a reality, but the unity of the visible church is a Godly command and calling. From this flows the calling of the church to deal with what keeps apart in a brotherly manner in order to bring together in one church denomination (Acta 1958:879-80, a.2.b).</p>
