Matters that the Synod take note of</p> <p>1.1 <i>Assignment:</i> Acta 2012:209, 3.1-3.3.</p> <p>1.1.1 The appointed Deputies are given the assignment to arrange the further management of the Thuso fund in terms of the Stipulations.</p> <p>1.1.2 Execute all matters over which the Synod has decided.</p> <p>1.1.3 Emeritus reverends and the widows of emeritus reverends continuously join Thuso.</p> <p>1.1.4 The state of the Thuso Fund is reflected in the attached financial statements.</p> <p>2. Matters that the Synod decide on</p> <p>2.1 Deputies are appointed to manage the Thuso Fund according to the Stipulations.</p> <p>2.2 The to-be-appointed Deputies enact the decisions made by the Synod.</p> <p>2.3 Classes are seriously requested to continuously inquire to whether all emeritus reverends and the widows of emeritus reverends in each respective Classis, for whom Thuso is intended, has indeed joined the fund; and to immediately pass on the information to the Deputies.</p> <p>2.4 The Synod takes note of the state of the Thuso Fund for emeriti with gratitude to the Lord.</p> <p>2.5 The Deputies recommend allocating 2 collections to the Thuso Fund.</p>
