Matters that the Synod take note of</p> <p>1.1 <i>Briefing</i>: Acts 2015:444.</p> <p>1.1.1 To arrange the broadcasting of sermons, church news and the participation in religious programmes on behalf of the Reformed Churches of South Africa in cooperation with Pretoria FM, the SABC (Triple M Productions), Radio Pulpit and other licensed broadcasters.</p> <p>1.2 <i>Implementation of brief</i> The broadcasting of sermons, church news and participation in religious programmes has taken place on a regular base on Pretoria FM and on various occasions on the SABC (RSG).</p> <p>1.3 <i>Broadcasting opportunities</i></p> <p>1.3.1 <u>Pretoria FM</u> Pretoria FM's religious programmes committee allocates religious broadcasting opportunities on an equal base to the four Reformed Church denominations, including the Reformed Churches in South Africa. Relevant church news as provided by the Administrative Bureau, is broadcasted on Pretoria FM on Sunday mornings. Rev HL Stavast, and at a later stage Rev C Jooste, as Deputies of the Reformed Churches in South Africa, attended various meetings with the religious programmes committee of Pretoria FM and provided their necessary inputs.</p> <p>1.3.2 <u>RSG</u> Triple M Productions, being authorised by the SABC to organise religious programmes on behalf of RSG, does not approach the Deputies as coordinators on behalf of the Reformed Churches in South Africa but rather approaches the ministers directly. Matters that the Synod decide on <u>Recommendations</u></p> <p>2.1 That Deputies be appointed with the brief to:</p> <p>2.1.1 Arrange the broadcasting of sermons, church news and the participation in religious programmes on behalf of the Reformed Churches in South Africa in cooperation with Pretoria FM, the SABC (Triple M Productions), Radio Pulpit and other licensed broadcasters.</p> <p>2.1.2 Request other Regional Synods to appoint Deputies for broadcasting purposes, representative of all Classes in the relevant Regional Synod. The <u>motivation</u> behind this argument is that independent broadcasters exist within the geographic areas of all Classes and Regional Synods of which the National Deputies are not always aware. Apart from not always being aware of these broadcasters the national Deputies do not know their locations or have their contact details.</p>
