Sake waarvan die Sinode kennis neem</p> <p>2.1 Vir die stand van die Sustentasiefonds word u verwys na die finansiële state van die Administratiewe Buro.</p> <p>2.2 <i>Aansoeke</i></p> <p>2.2.1 Ten spyte van herhaalde versoeke en van die verduidelikende notas, was sekere kerke se aansoeke nie volledig nie en het dit nie aan al die vereistes van die Reglement voldoen nie. Daar was ook aansoeke van kerke wat keurig en netjies versorg was met al die nodige inligting en verduidelikings. Sommige Klassisse het baie deeglike werk gedoen, terwyl ander hulle verantwoordelikheid om die aansoek te motiveer, nagelaat het.</p> <p>2.2.2 Aansoeke is op dieselfde wyse as in die verlede behandel en beoordeel volgens die Reglement. Kerke wat aansoek doen om sustentasie, is gevra vir 'n bedieningsplan sodat die wyse waarop die kerk sy roeping wil nakom, duidelik is.</p> <p>2.2.3 Die aansoeke van kerke by die Sustentasiefonds vir 2016 was R4 702 460. Matters that the Synod take note of</p> <p>2.1 See financial statements of the Administrative Bureau for the status of the Sustentation fund.</p> <p>2.2 <i>Applications</i></p> <p>2.2.1 Despite repeated requests and the explanatory notes, certain churches' applications were still not complete and did not meet all the requirements of the procedural rules. There were also applications that were neat and well-presented, containing all the necessary information and clarifications. Some Classes were very thorough, while others neglected to motivate their application.</p> <p>2.2.2 Applications were reviewed as always and assessed against the procedural rules. Churches applying for sustentation were requested to provide a ministry plan in explanation of how the church aims to fulfil its calling.</p> <p>2.2.3 The applications to the Sustentation fund for 2016 came to R4 702 460 and the Deputies awarded an amount R2 750 000.</p> <p>2.2.4 The applications to the Sustentation fund for 2017 came to R5 125 933. The Deputies provided sustentation of R1 859 000.</p> <p>2.2.5 The applications to the Sustentation fund for 2018 came to R4 008 509</p>
