Matters that the Synod take note of</p> <p>2.1 The <i>Sponsor a Bible</i> project is now considered the standard for collecting funds for Bible distribution. <u>Note:</u> The amount to be collected is equal to and keeps track with the cost price of the Standard Bible (black hard cover Bible). However, the project has undergone a transformation with the aim of making it more attractive and interactive: The old envelope system has been replaced with pill holders with a <i>Sponsor a Bible</i> sticker to identify the container. The aim is to fill it with R5 pieces to make up the amount needed for a standard Bible.</p>

The vision of the BSA is “a Bible for everyone”</i></p> <p>2.3.1 To achieve this, the Standard Bible must be kept as affordable as possible and the price is currently R97.00.</p> <p>2.3.2 An Outreach Bible at R55.00 is also available to the poor. Annually, large numbers of Bibles (± 22 744) are made available to the poor, mainly through churches and groups serving the poor.</p> <p>2.3.3 About 32 249 Outreach Bibles are also given to Grade 7s annually.</p> <p>2.3.4 The Word is also given to pre-school and grade 1 children, largely free of charge, through a set of workbooks (My eerste Bybel-Doen en Leer) through which they can learn to read and write with the Bible as basis. 174 563 annually.</p> <p>2.3.5 Bibles are still given to the prisoners so that they can read, repent and rehabilitate through the Word. Matters that the Synod take note of</p> <p>1.1 The Deputies would like to make the following suggestions regarding the appointment of a new Liaison officer in 2020, so that he can take over at br H Dekker who left the BSA's service by the end of 2020. Br Dekker's official retirement date is already January 2020, but because the Bible Society celebrates its 200 year anniversary in 2020, br Dekker asked to stay on until 2020, after the celebrations were completed.</p> <p>The Bible Society has put new ways of working to increase the scope of the Liaison deputy (Organizers in general) so that more congregations can be visited more frequently. There are various options considered by the Deputies on this basis and we would like to submit the following 2 options for consideration with the aim of approving one method.</p> <p>1.1.1 <u>Option one</u> 2 candidates/ministers are appointed on a part-time 50/50 basis: One in Johannesburg and one in Pretoria. Therefore, if they are ministers, they will serve about half of their time within the congregation and the rest to fulfill the responsibilities of the Bible Society,</p>

It will be expected of him to fulfill some obligations in the other major centers of the country, such as conferences and visits once a year to towns in or Cape Town or Port Elizabeth or Bloemfontein or Durban to make a meaningful cycle.</p> <p>Salaries are also divided 50/50; the BSA pays a negotiated/agreed amount and the municipality the rest. The BSA/Deputies Bible will therefore negotiate with the Church Council and the preacher, so that both will be beneficial and contracts will be adjusted and signed with the minister. The BSA therefore pays approximately 50% of the salary and the municipality to the rest.</p> <p>1.1.2 <u>Option two</u> The status quo is maintained and one person is appointed to the BSA on a full-time basis. As a minister can not be employed by the BSA on a full-time basis, a non-minister will be recruited and appointed according to the guidelines (advertisement) compiled by the BSA and based on the current contract as applicable to the post which br H Dekker currently holds.</p> <p>1.2 <i>The Deputies Bible</i> It should be further considered that the Deputies Bible will, as part of an extended assignment, recruit in the large center of staff, in collaboration with the Liaison deputy/ies, to extend their scope. It will take the form where preaching ministers, after receiving and supervising equipment, preach from time to time at nearby congregations and pass the BSA's activities to the congregations. The BSA will give a ministerial sermon to the ministers. This will make both options more viable so that more congregations will be visited more frequently.</p> <p>Decision: Points 1.1 and 1.2 noted.</p>
