Opdrag</p> <p>1.1 Die Deputate kry opnuut die opdrag om sendingsamewerking van buitelandse kerke in Suid-Afrika en ander lande in Afrika en elders in die wêreld te koördineer deur inligting daaroor beskikbaar te maak aan die kerke en waar moontlik advies te gee ten einde goeie en ordelike samewerkingsooreenkomste te fasiliteer tussen binnelandse en buitelandse saamwerkende kerke.</p> <p>1.2 Die Deputate gaan verder met gesprekke met GK Wapadrant, ander Gereformeerde Kerke en Missionet oor die vestiging van 'n databasis met inligting oor waar kerke in Suid-Afrika betrokke is by sendingwerk in die buiteland.</p> <p><u>Vir kennisname</u></p> <p>1.3 <u>Uitvoering van opdrag</u></p> <p>1.3.1 In samewerking met GK Centurion het die Deputate 'n sendingkonferensie op 24 Oktober 2015 aangebied wat gegaan het oor sendingwerk in Afrika en die koördinering van hierdie sendingwerk.</p> <p>1.3.2 In samewerking met GK Pretoria-Brooklyn het die Deputate 'n sendingkonferensie op 13 Februarie 2016 aangebied. Tydens hierdie konferensie is opleiding gegee oor kontekstualisering, kulturele sensitiviteit en die uitdra van die evangelie. Plaaslike kerke het ook die geleentheid gehad om mekaar uit te nooi om vennote te word in sending-</p>	<p>1. Mandate</p> <p>1.1 The Deputies are instructed anew to coordinate mission work of international churches in South Africa, other African countries and elsewhere in the world by providing information in this regard to the churches and where possible, offering advice to facilitate good and orderly cooperation agreements between local and international cooperating churches.</p> <p>1.2 The Deputies are to continue discussions with GK Wapadrant, other Reformed Churches and Missionet on establishing a database providing information on where South African churches are involved in mission work abroad.</p> <p><u>To be noted</u></p> <p>1.3 <u>Execution of mandate</u></p> <p>1.3.1 The Deputies presented, in collaboration with GK Centurion, a mission conference on 24 October 2015 about mission work in Africa and its coordination.</p> <p>1.3.2 The Deputies presented, in collaboration with GK Pretoria-Brooklyn, a mission conference on 13 February 2016. During the conference training was offered on contextualisation, cultural sensitivity and proclaiming the gospel. Local churches also had the opportunity to form partnership with each other for mission work.</p>

<p>werk.</p> <p>1.3.3 Die Deputate het aan plaaslike kerke advies gegee oor moontlike nuwe sendingterreine en, indien nodig, is hierdie sendingterreine besoek.</p> <p>1.3.4 Die Deputate het gesprekke gevoer met GK Wonderboompoort oor die gebruik van hulle kerkkantoor en administratiewe beampte vir 'n sendingkantoor. 'n Samewerkings-ooreenkoms is onderteken waarvolgens GK Wonderboompoort hulle kerkkantoor en administratiewe beampte een dag per week beskikbaar stel as 'n sendingkantoor vir die GKSA.</p> <p>1.3.5 Die sendingkantoor samel inligting in oor sendingwerk wat deur plaaslike kerke van die GKSA gedoen word. Die kantoor maak ook toerustingsmateriaal oor sendingwerk bymekaar en help met die reëlings van konferensies. Al hierdie inligting word op die webblad van die GKSA geplaas.</p> <p>1.3.6 Die Deputate het gereeld met die sendingkantoor vergader oor die vordering van die werk. Die sendingkantoor is finansiële ondersteun deur GK Centurion, Wonderboompoort en Pretoria-Annlin.</p> <p>1.3.7 Die Deputate het met die sendingdeputate vergader wat 'n sendingorde opgestel het. Volgens die opgestelde sendingorde sal sendingkoördinering voortaan deur die Sendingdeputate gedoen word.</p>	<p>1.3.3 The Deputies advised local churches on possible new mission fields and, if necessary, these mission fields were visited.</p> <p>1.3.4 The Deputies discussed with GK Wonderboompoort the use of their church office and administrative officer for a mission office. A cooperation agreement was entered into, in which GK Wonderboompoort makes their church office and administrative officer available one day per week as mission office for the GKSA.</p> <p>1.3.5 The mission office gathers information on mission work done by local GKSA churches. The office also obtains equipping material on mission work and assists with the arrangement of conferences. All this information was placed on the GKSA's website.</p> <p>1.3.6 The Deputies regularly met with the mission office over the progress of the work. The mission office is financially supported by GK Centurion, Wonderboompoort and Pretoria-Annlin.</p> <p>1.3.7 The Deputies met with the Deputies: Mission who drafted a mission order. According to the mission order, mission coordination will henceforth be done by the Deputies: Mission.</p>
<p>Besluit: Punte 1.1 tot 1.3.7 kennis geneem.</p> <p><u>Vir besluitneming</u></p> <p>1.4 <i>Aanbevelings (Opdragte aan te benoemde Deputate)</i> Indien die sendingorde (wat die Sendingdeputate opgestel het) goedgekeur word, word sendingkoördinering nie meer deur die ekumeniese Deputate hanteer nie, maar deur die Sendingdeputate.</p> <p>Besluit: Goedgekeur.</p>	<p>Decision: Points 1.1 to 1.3.7 noted.</p> <p><u>To be decided</u></p> <p>1.4 <i>Recommendations (Mandate to the appointed Deputies)</i> Should the drafted mission order (the Deputies: Mission) be approved, mission coordination will no longer be the task of the Deputies: Ecumenicity, but that of the Deputies: Mission.</p> <p>Decision: Approved.</p>
