Matters that the Synod take note of</p> <p>1.1 <i>Synod assignments</i></p> <p>1.1.1 <i>The Trustees of the Fund are empowered to raise additional contributions for the Support Fund when necessary, and to obtain these additional contributions, as calculated by an Actuary, by means of an appeal to gather voluntary contributions for this purpose.</i></p> <p>There was no need for the Trustees to make an appeal in the denomination.</p> <p>1.1.2 <i>The Trustees have the assignment to organise the further management of the Support Fund according to the Regulations.</i></p> <p>1.1.2.1 The management of the Fund is organised according to the Regulations.</p> <p>1.1.2.2 The purpose of the Fund is formulated in the following way for the sake of clarity: The purpose of the FUND is to provide the MEMBERS with career disability advantages described therein including the time in which the member cannot be accommodated by his Church Council or while he is waiting for a vocation from another Church Council.</p> <p>Decision: Points 1.1 to 1.1.2.2 noted.</p> <p>2.
