Mandate: Acta 2015:244.</p> <p>1.1 The Deputies are to continue to manage the Deputies CE's section of the GKSA website.</p> <p>1.2 The Deputies are to consider anew the objective of the database of Christian educators. New initiatives could be undertaken to achieve the overall objective of the Deputies CE.</p> <p>1.3 The Deputies are to keep the congregations and members abreast of existing and new information related to Christian education.</p> <p>1.4 <i>Church councils are called to</i></p> <p>1.4.1 encourage members to stand for election and to participate in the election process of governing bodies at schools;</p> <p>1.4.2 encourage the Christian youth to qualify themselves as Christian educators, among which institutions such as Aros and the NWU could be invaluable;</p> <p>1.4.3 launch initiatives in an endeavour to promote Christian values and moral conduct in communities that its instruction in schools may be more effective; and</p> <p>1.4.4 support local schools, governing bodies and teachers by determining the aid that could be offered to schools within their communities.</p> <p>Decision: Points 1.1 to 1.4.4 noted.</p>

Sake waarvan die Sinode kennis neem</p> <p>2.1 <i>Oor opdrag 1.1–1.2</i></p> <p>2.1.1 Die praktyk van die afgelope 3 jaar, asook die 3 jaar voor dit, was dat die CO-deputate nie werklik die webblad benut nie. In die toekoms sal dit dalk handig wees en die opdrag kan kontinueer.</p> <p>2.1.2 Die Deputate het gepoog om die databasis tot stand te bring, maar sonder sukses.</p> <p>2.1.2.1 Uit die hele GKSA het daar slegs die inligting van 69 onderwysers ingekom.</p> <p>2.1.2.2 Dit sal ook 'n voltydse taak wees om te behartig. Die Deputate kan dit dus nie doen nie.</p> <p>2.1.2.3 ARSO en ICO is wel tans besig om 'n soortgelyke databasis op te stel. Ons kan dus eerder die gemeentes aanspoor om hieraan deel te neem.</p> <p>2.2 <i>Oor opdrag 1.3-1.4</i></p> <p>2.2.1 Die Deputate kommunikeer met die gemeentes van die GKSA om sodanige inligting met hul te deel.</p> <p>2.2.2 Wat wel genoem kan word is dat die Kuratore van TSP, AROS en ICO, asook die NWU, self direk met die gemeentes kommunikeer. Resente inligting word deur hulle gedeel en Kerkrade ontvang dit dus direk.</p> <p>2.2.3 Die opdrag kan ook kontinueer.</p> <p>Besluit: Punte 2.1 tot 2.2.3 kennis geneem.</p>	<p>2. Matters that the Synod take note of</p> <p>2.1 <i>Instructions 1.1-1.2</i></p> <p>2.1.1 The Deputies CE didn't much use the website the past 3 years, as well as the 3 years preceding that. It may become of benefit in future and the instruction can be continued.</p> <p>2.1.2 The Deputies attempted to establish a database, but failed for the following reasons</p> <p>2.1.2.1 Only information on 69 educators was received from the whole of the GKSA.</p> <p>2.1.2.2 It would be a full-time task to manage and thus the Deputies would not be able to do so.</p> <p>2.1.2.3 ARSO and ICO have already undertaken to establish a similar database. We should rather encourage the churches to participate in this endeavour.</p> <p>2.2 <i>Instruction 1.3-1.4</i></p> <p>2.2.1 The Deputies communicated this information to the churches of the GKSA.</p> <p>2.2.2 It should be mentioned that the Curators of the TSP, AROS and ICO as well as the NWU also communicate with the congregations directly. Recent information is directly conveyed to Church Councils.</p> <p>2.2.3 The instruction should also continue.</p> <p>Decision: Points 2.1 to 2.2.3 noted.</p>
