Opdrag</p> <p>1.1 Na aanleiding van die noodsaak om oor Christelike onderwys in Suid-Afrika te besin, word die Deputate versoek om 'n kongres saam met ander belanghebbende organisasies en kerke soos die NG, NH en AP-kerke te reël. So 'n kongres kan oor die stand van sake ten opsigte van Christelike onderwys in die breë, besin.</p> <p>1.2 Die Sinode word gevra om voort te gaan met die besluit dat gemeentes versoek word om te kollekteer sodat ARSO kan voortgaan met die ontwikkeling van 'n Christelike kurrikulum vir gebruik in openbare en private skole.</p> <p>1.3 Kerkrade word versoek om in die lig van onder meer KO, art 21 en HK, Sondag 38 aandag aan die onderwys (in besonder die kurrikulum wat verbondskinders volg) te gee.</p> <p>Besluit: Punte 1.1 tot 1.3 kennis geneem.</p> <p>2. Sake waarvan die Sinode kennis neem</p> <p>2.1 Die Deputate is besig om 'n kongres te organiseer oor Christelike onderwys in Suid-Afrika. Dit was vir ons duidelik dat onself vanweë kapasiteit baie moeilik so 'n groot kongres op ons eie gaan kan aanpak. Daarom het ons begin om in samewerking met die Instituut vir Christelike onderwys hierdie saak aan te pak en dit behoort gedurende 2018 te realiseer.</p> <p>2.2 Gemeentes het ruim in kollektes bygedra vir kurrikuleringontwikkeling. Mandate</p> <p>1.1 Given the need to reconsider Christian education in South Africa the Deputies are to arrange a conference with other stakeholder organisations and churches like the NG, NH and AP churches to take a broad look at Christian education.</p> <p>1.2 The Synod is requested to continue requesting congregations to have collections for ARSO to proceed with the development of a Christian curriculum, for implementation in public and private schools.</p> <p>1.3 Church Councils are requested to give attention to education (especially the curriculum the children follow), in light of <i>inter alia</i> CO, art 21 and HC, Sunday 38.</p> <p>Decision: Points 1.1 to 1.3 noted.</p> <p>2. Matters that the Synod take note of</p> <p>2.1 The Deputies are arranging a conference on Christian education in South Africa. It became clear that due to capacity it would be very difficult for us to undertake such a large conference on our own and so we have partnered with the Institute for Christian Education, which should become a reality during 2018.</p> <p>2.2 Congregations generously contributed to curriculum development by means of collections. We are sincerely grateful! ARSO (now called the Institute for Christian Education) is making good</p>

Die kurrikulum moet toeganklik en bruikbaar wees vir openbare skole, daarom het ons die hele aanslag van die verlede verander.</p> <p>2.3.2 <u>Die volgende sake het aandag geniet</u></p> <p>2.3.2.1 Die titel van die kurrikulum is die Waterstroomreeks. Dit het 'n tweeledige betekenis. Eerstens is Christus die bron van alle kennis en Hy is ook die lewende water. Dit is tog ook wat ons moet verkondig. Tweedens moet 'n gesonde waterstroom nie stilstaan nie, ons glo dit is ook van toepassing op ons kurrikulum, dit moet voortdurend ontwikkel word, daar moet dus intellektuele vloei plaasvind.</p> <p>2.3.2.2 Die kurrikulum voldoen aan die KABV/CAPS standaarde en word intensief verryk.</p> <p>2.3.2.3 Daar word gewaak teen die ontwikkeling van 'n kurrikulum met 'n Christelike sousie, dit moet 'n ware geïntegreerde Godgesentreerde kurrikulum wees.</p> <p>2.3.2.4 Drie hoofmomente hiervan is vaardighede, kennis en waardes.</p> <p>2.3.2.5 Die waardes is die goue moment van die kurrikulum. Hierdie waardes is in drie hoofkomponente verdeel nl Godsaanskouing, Mensbeskouing en Skeppingsbeskouing. Vir die kind is dit vertaal in Wie is God? Wie is jy? en Wat moet jy doen? (roeping). Hierdie drie komponente moet voortdurend die kennis aan die kind ontsluit. Dit is die bril waardeur hy na die kennis moet kyk.</p> <p>2.3.2.6 Die Christenonderwyser in die openbare skool kan hierdie kurrikulum ook met groot vrug gebruik.</p> <p>2.3.2.7 Daar word ook gewerk aan materiaal wat die kurrikulum tegnologies verryk. Hiervoor maak ons gebruik van 'n oud adjunkhoof en 'n grafiese ontwerper wat hulle kennis met ons deel.</p>	<p>progress in completing the curriculum for private schools, public schools and home schooling.</p> <p>2.3 <i>Regarding curriculating</i></p> <p>2.3.1 It is tremendously labour intensive and great progress could be made due to the sturdy foundation of predecessors. The curriculum needs to be accessible and useful to public schools and so we adapted the entire approach of the past.</p> <p>2.3.2 <u>The following aspects were addressed</u></p> <p>2.3.2.1 The curriculum is called the Waterstroomreeks (Water Stream Series), which has a two-fold meaning. Firstly, Christ is the source of all knowledge and He is also the living water, which is after all what we proclaim. Secondly, a strong water stream cannot remain static and we believe this to be applicable to our curriculum, which should always be developing - i.e. intellectual flow.</p> <p>2.3.2.2 The curriculum complies with the KABV/CAPS standards and is intensively supplemented.</p> <p>2.3.2.3 Care is taken to avoid the development of a curriculum with a Christian veneer, it must be a truly integrated God-centred curriculum.</p> <p>2.3.2.4 Its three main components are skills, knowledge and values.</p> <p>2.3.2.5 The values component is its golden feature. This component comprises three main elements, namely reflecting on God, reflecting on man and reflecting on creation. It is simplified for the child into Who is God?, Who are you? and What must you do? (calling). These three components are the means by which the child is to process knowledge or the lens through which he must view knowledge.</p> <p>2.3.2.6 The curriculum could also be of great benefit to Christian teachers in public schools.</p> <p>2.3.2.7 Material is being developed to enrich the curriculum technologically, with the aid of a former vice-principal and graphic designer.</p>
