Sake waarvan die Sinode kennis neem</b></p> <p>2.1 <i>Aard van die werksaamhede van die Deputate vir Regsaangeleentehede</i></p> <p>2.1.1 Verskeie kerke en kerklike instansies waaronder plaaslike kerke, Deputate-groepe, die Administratiewe Buro en die Kuratorium het die Deputate om regsadvies genader.</p> <p>2.1.2 Hieronder word die belangrikste sake aangedui waarvoor advies of leiding gevra is, en waarmee die Deputate hulle ter uitvoering van hul opdragte besig gehou het.</p> <p>2.1.3 Die aard van die werksaamhede van die Deputate is soms sodanig dat advies telefonies en/of mondelings gegee moet word, insover dit moontlik is. Matters that the Synod take note of</b></p> <p>2.1 <i>Nature of work of the Deputies Legal Affairs</i></p> <p>2.1.1 Different churches and church institutions among which local churches, Deputy groups, the Administrative Bureau and the Curatorium approached the Deputies for legal advice.</p> <p>2.1.2 The most important matters, on which advice or guidance were sought and with which the Deputies were occupied in the execution of their mandate, are detailed below.</p> <p>2.1.3 The nature of the work of the Deputies sometimes requires giving advice telephonically and/or orally, as far as possible. The Deputies met several times to address more complex or important matters and requests.</p> <p>2.1.4 Regarding the work of the Deputies, it should be pointed out that the term predominantly centred on the establishment of a Pentecostalism professorship for research at the Faculty of Theology.</p> <p><b>Decision: Points 2.1 to 2.1.4 noted.</b></p>
