Sake waarvan die Sinode kennis neem</p> <p>2.1. <i>Insake die verskaffing van dokumente</i> 2.1.1. Weens die bloot administratiewe aard van die opdrag, is die Deputate nie opgeroep vir 'n vergadering nie om sodoende ook reiskoste te bespaar.</p> <p>2.1.2. Die Belydenisskrifte, Liturgiese Formuliere en Gebede van die kerke vanuit die voormalige Middellande is nie geredelik beskikbaar nie. Verskeie navrae is gerig en daar is wel enkele stukke van verskillende persone ontvang.</p> <p>2.1.3. Feitlik geen Belydenisskrifte, Liturgiese Formuliere en Gebede in die tale van die kerke vanuit die voormalige Middellande is beskikbaar by die Administratiewe Buro nie. Mandate Acta 2015:424. 2.2 The Synod gives instruction to the Deputies Doctrinal Matters to provide the following documents to the appointed Deputies in all languages used by the churches: 2.2.1 Creeds of confession 2.2.2 Liturgical formularies 2.2.3 Prayers 2.3 The Synod gives instruction to the Deputies Doctrinal Matters to liaison with the Deputies to be appointed.</p> <p>Decision: Noted.</p> <p>2. Matters that the Synod take note of</p> <p>2.1. <i>Concerning the provision of documents</i> 2.1.1. Owing to the purely administrative nature of the assignment, the Deputies were not called for a meeting, also in order to save the cost of traveling expenses.</p> <p>2.1.2. The Creeds of Confession, Liturgical Formularies and Prayers from the former Midlands churches are not readily available. Several inquiries have been made and some pieces were received from different persons.</p> <p>2.1.3. Virtually no Creeds of Confession, Liturgical Formularies and Prayers in the languages from the former Midlands churches are available from the Administrative Bureau. There is apparently no (or almost no) enquiry to provide these. Consequently, there is no effort to keep or to get hold of it.</p>

The English text are used by nearly all the former Midlands churches. This text could not yet be finalised, as the standard Afrikaans text still has to be finalised and proof-read.</p> <p>2.2. <i>Request received from GK Centurion on 26 May 2017 on the review of Alternative Formularies as approved by Classis Pretoria South West</i></p> <p>2.2.1. No such instruction was received by the deputies from Synod 2015 (see 1 above). Deputies receive their instructions from the meeting that nominated them (CO, art 49) and therefore did not deal with this matter.</p> <p>2.2.2. To Rev M van Helden was recommended that Classis Pretoria South West or GK Centurion put a Point of Description on the Agenda of Synod 2018 to consider and decide on the matter of Alternative Formularies.</p> <p>Decision: Points 2.1 to 2.2.2 noted.</p> <p>3. Matters that the Synod decide on</p> <p>3.1. That the standard Afrikaans text of the Creed of Confessions, Liturgical Formularies and Prayers that have been submitted and approved, serves as the GKSA's official standard text for all translations.</p> <p>3.2. That the English translation as it appears on the website of the GKSA (cjbfc.co.za) be used until the English translation (that should be translated from the official standard Afrikaans text), is completed.</p> <p>3.3. That the Deputies Reformed Publications can continue to print the approved standard Afrikaans text and translations based on that text. All changes made in future to the standard Afrikaans text must be adjusted in all existing translations.</p> <p>3.4.
