<p><b>1. Opdrag</b> Die opdrag is vervat in die Reglement van die Evangeliseringssmediafonds (Acta 2006:766-770). Die administrasie daarvan word namens die Deputate deur die Administratiewe Buro behartig. Aandag is aan onafgehandelde sake van vorige Deputate gegee. <b>Besluit:</b> Kennis geneem.</p> <p><b>2. Sake waarvan die Sinode kennis neem</b></p> <p>2.1 <i>Afsterwe van br Jannie Earle</i> Die Deputate moes met leedwese gedurende Oktober 2016 verneem van die afsterwe van br Jannie Earle in 'n tragiese skietvoerval in die kompleks waarin hy woonagtig was. Sy afsterwe het 'n groot leemte by die Deputate gelaat waar hy 'n reuse bydrae gelewer het. Die Deputate het egter besluit om nie iemand anders te koöpteer nie aangesien die termyn binnekort sou verstryk.</p> <p>2.2 <i>Hospitaal, Pastorale en Evangelisasie lektuur</i></p> <p>2.2.1 Die Deputate het verskeie pogings aangewend om predikante en emeriti te vra om 'n Hospitaal, Pastorale en Evangelisasie lektuur te skryf. Reaksie op hierdie versoek het egter min opgelewer en die Deputate het besluit om uit eie geledere lektuur beskikbaar te maak.</p> <p>2.2.2 Daar is ook aan Setwana en Sesothosprekende predikante gevra vir preke, dagstukkies en ander lektuur. Op hierdie versoek was daar geen reaksie nie.</p> <p>2.2.3 "Brood van die Lewe" is deur prof JA van Rooy in Venda vertaal. Daar is 'n</p>	<p><b>1. Mandate</b> The mandate is included in the Regulations of the Evangelism media fund (Acta 2006:766-770). The administration thereof is done by the Admin Bureau on behalf of the Deputies. Attention was paid to unfinished matters of the previous Deputies. <b>Decision:</b> Noted.</p> <p><b>2. Matters that the Synod take note on</b></p> <p>2.1 <i>Death of br Jannie Earle</i> The Deputies had to acknowledge with sadness the death of br Jannie Earle in October 2016, in a tragic shooting at the complex where he lived at the time. His death has left a void with the Deputies where he made an enormous contribution. The Deputies however decided not to co-opt someone else as the term would be over shortly.</p> <p>2.2 <i>Hospital, Pastoral and Evangelism literature</i></p> <p>2.2.1 The Deputies have endeavoured in several ways of requesting reverends, and emeriti to write Hospital, Pastoral and Evangelism literature. These requests did not bear fruit and the Deputies decided to provide literature from within the Deputies itself.</p> <p>2.2.2 Sesotho and Setswana reverends were also approached for sermons, daily devotionals and other literature. This request was met with no response.</p> <p>2.2.3 "Brood van die Lewe" was translated by prof JA van Rooy into Venda. A</p>

It was thus decided not to publish the booklet.</p>
2.2.5	<p>Wyle prof PJ de Bruyn se boek "Salf vir die Wonde" is deur hom opgesom vir plasing op die CJBF-webblad. Hy kon egter nie die werk voltooi voor hy oorlede is nie. Daar is volstaan met die gedeeltes wat hy voltooi het.</p>	<p>2.2.5 The late prof PJ de Bruyn's book "Salf vir die Wonde" was summarised by him for placement on the CJBF website. However, he could not complete the work before his death. The parts that were finished are viewed as sufficient.</p>
2.2.6	<p>Dagstukkies uit vorige uitgawes van die Almanak wat geskik is as hospitaal-, pastorale- en evangelisingslektuur is omskep in 3-vou traktate en van geskikte voorblad voorsien. 'n Aantal daarvan (300 elk van 20 traktate) is gedruk en is beskikbaar by die Admin Buro teen 'n donasie. Dit is ook beskikbaar op die CJBF-webblad om gratis afgelaai te word en self gedruk te word. Die beskikbaarheid van die traktate is dmv plakkate by gemeentes geadverteer.</p>	<p>2.2.6 Daily devotionals from previous editions of the <i>Almanak</i> which are suitable for hospital, pastoral, and evangelism literature has been changed into 3-fold leaflets and provided of suitable cover pages. A number of these (300 each of 20 leaflets) were printed and are available from the Admin Bureau for a donation. They are also available on the CJBF website for free download and personal printing. The availability of the leaflets has been advertised in congregations by means of posters.</p>

Two additional anthologies ("Morena Jehova wa bua" and "Mofao Tseleng ya Moetsadibe" – Provisions for the Sinner) are in the process of being scanned.</p>
