Fondse om dit te vertaal was nie beskikbaar nie (http://diewilvangod.co.za/wp-login.php <u>Gebuiks-en toegangswoorde beskikbaar by Voorsitter: Kerkgroeibediening</u>)</p> <p>2.2 Die statistiek in die <i>Almanak</i> is nagevors en geëvalueer om tendense daaruit af te lei en om 'n bydrae te lewer in die beplanning en evaluering van ons gemeentes.</p> <p>2.3 Deputate moes <i>moontlike navorsingsonderwerpe of onderwerpe/nood</i> vanuit praktiese situasies na die werkgroep verantwoordelik vir hierdie opdrag ver-</p>	<p>1. Mandate Acta 2015:517, 6.4.5. “6.4.5 Explore the further deepening of the church growth ministry, suggest the next levels of implementation and advise the Synod accordingly in cooperation with the CMTG and in reference to new research that may come to light”.</p> <p>2. Matters that the Synod take note of <i>Terminology applied in this Report: Newly included congregations refer to the 162 congregations which were included in the GKSA. Existing congregations refer to GKSA-congregations which existed before the 162 congregations were included into the GKSA.</i></p> <p>2.1 The internet web page tool regarding churchgrowth was compiled by Phia van Helden and evaluated for use in the churches. Funds in order to translate the website was not available (http://diewilvangod.co.za/wp-login.php Gebuiks-en toegangswoorde beskikbaar by Voorsitter: Kerkgroeibediening).</p> <p>2.2 The statistics in the GKSA Almanak was researched and evaluated to draw relevant trends in order to assist planning for and evaluation of our churches.</p> <p>2.3 Deputies must refer <i>possible topics of research</i> to this workgroup if and when they arise from practical situations and the needs in our churches. Prof Steyn was deel van die navorsingsprojek.</p> <p>2.7 Ten spyte van toegewyde werk wat gedoen is deur die Deputate Kerk-groei-bediening, is struikelblokke geïdentifiseer buite die gestelde doel-witte vir Kerkgroei-bediening. Hieronder word die tendense en struikelblokke uiteengesit.</p> <p>2.7.1 'n Webblad gerig op kerkgroei is beskikbaar (http://diewilvangod.co.za/wp-login.php) vir enigeen wat meen dat kennis hieroor tekort skiet. 'n Aantal individue het aanvanklik daarvan gebruik gemaak, maar op die lang duur word die webblad nie besoek nie. Die nuuttoegevoegde gemeentes het weens taal en gebrekkige elektroniese vaardighede en geleenthede, nie van die webblad gebruik gemaak nie.</p> <p>2.7.2 Daar is nie begroot om hierdie webblad te vertaal, of op 'n ander manier toeganklik te maak vir die nuuttoegevoegde gemeentes nie.</p> <p>2.7.3 Navorsing toon dat kommunikasie binne die kerkverband 'n ernstige struikelblok is. Van die nuuttoegevoegde gemeentes het nie toegang</p>	<p>research was received from the Deputies, although a research inquiry was received regarding elders and the shortage of pastors in the Cape Flats. Research is stored in the churchgrowth data bank.</p> <p>2.4 Research on current secular and cultural trends was done. Relative information and implications were published in <i>In die Skriflig/In Luce Verbum</i> to be of value for the congregations. Each article was e-mailed to each existing congregation in the GKSA.</p> <p>2.5 Attention was given to the development of a questionnaire by which the needs in the churches could be established. The results were published in <i>In die Skriflig/In Luce Verbum</i>. This article was e-mailed to each existing congregation in the GKSA.</p> <p>2.6 Jan Geertsema was nominated as an additional member to assist in the research and interpretation of the research. Prof Faans Steyn was recommended by Jan Geertsema in his stead. Prof Steyn was part of the research project.</p> <p>2.7 In spite of dedicated work done by die Deputies concerned with churchgrowth, stumbling blocks were identified which were not part of the aims of the churchgrowth ministry. The stumbling blocks and tendencies are hereby set out.</p> <p>2.7.1 A web page regarding churchgrowth is available for anyone who would like to gain more knowledge on this topic (http://diewilvangod.co.za/wp-login.php). Initially the web page was visited, but recent visits do not take place. The newly included congregations did not visit the web page due to the language and the lack of electronically based skills.</p> <p>2.7.2 Translation of the web site was not budgeted for or to make it accessible for the newly included congregations.</p> <p>2.7.3 Research revealed that communication is a major stumbling block within the GKSA. Many of the newly included congregations do not have internet.</p>

Kommunikasie deur middel van e-posse en selfoongebruik is grootliks oneffektief.</p> <p>2.7.4 Meeste van die nuuttoegevoegde gemeentes is in 'n oorlewingstryd as gevolg van armoede. 'n Groot aantal bestaande gemeentes voer ook 'n oorlewingstryd as gevolg van krimpende getalle. Die gevolg is dat daar gemeentes besig is met elkeen se oorlewingstryd. Daar is nie tyd of energie om op iets anders soos kerk-groei, te fokus nie;</p> <p>2.7.5 'n Groot aantal GKSA-gemeentes stel nie belang in die aanpak vir die kerk-groei-bediening nie.</p> <p>2.7.6 Navorsing het getoon dat groot onkunde en onbevoegdheid by die nuuttoegevoegde gemeentes nie net op die vlak van kommunikasie bestaan nie, maar ewe sterk ook in die volgende aspekte: tydbeheer, beplanning, administrasie en verantwoordbaarheid. Hierdie gebreke kom baie sterk na vore in tye wanneer bv die insameling van data vir die jaarlikse <i>Almanak</i> plaasvind. Die resultate van die data soos dit in die <i>Almanak</i> verskyn, wys die stand van sake binne die GKSA se twee groepe gemeentes. Die <i>Almanak</i> is die GKSA se vertoonvenster en primêre bron vir algemene kennisname asook navorsing. Die bron beklemtoon die gebrek aan 'n geroepe gesindheid teenoor kerkgroei-bediening binne die GKSA. Van die GKSA-gemeentes toon nie net groot onkunde en onbevoegdheid nie, maar selfs ook onwilligheid wanneer Suid-Afrikanoed en Suid-Afrika-verhoudings ter sprake is. Dit verduidelik verder waarom min aandag gegee word aan die kerkgroei-bediening.</p> <p>2.7.7 In baie plattelandse gemeentes wat nuut toegevoeg is tot die GKSA, is die gebrek aan behoorlike geestelike bediening 'n akute struikelblok. Redes hiervoor is:</p> <p>2.7.7.1 Daar is baie vakante gemeentes met die gevolg dat geestelike bediening benadeel word.</p>	<p>The action of effective communication almost do not exist. This include communication by means of e-mails or cell phone calls.</p> <p>2.7.4 Most of the newly included congregations are caught up in a struggle for survival as a result of poverty, while a large number of existing congregations struggle to survive as result of declining numbers. Consequently the focus cannot be on anything else like churchgrowth.</p> <p>2.7.5 A large number of GKSA-congregations are interested in the approach of the churchgrowth ministry.</p> <p>2.7.6 Research reveals that great ignorance and incompetence exist amongst the newly included congregations. It manifests not only in the case of communication, but also in aspects like time control, planning, administration and accountability. The collection of data for the annual <i>Almanac</i> emphasizes this crisis in red. The GKSA <i>Almanac</i> and it's statistics are the showcase and prime source of GKSA congregational information and for research. The <i>Almanac</i> portrays the state of affairs in the two groupings of the GKSA. This source emphasizes the lack of a called attitude towards the churchgrowth ministry in the GKSA, as well as great ignorance and incompetence and even unwillingness when South African needs and relations are in question. This, amongst other things, also explains why very little attention is paid to the churchgrowth ministry.</p> <p>2.7.7 In many of the newly included rural congregations, the lack of proper spiritual ministry is a major stumbling block. Reasons for this are:</p> <p>2.7.7.1 There are many vacant congregations, consequently effecting proper spiritual pastoring.</p>

<p>2.7.7.2 Groot afstande, veral op die platteland, veroorsaak dat gebrek aan besoeke en gevolglik ook gebrek aan geestelike bediening, 'n reuse struikelblok is.</p> <p>2.7.7.3 Verder is die gebrek aan geld vir vervoer ter wille van geestelike bediening, 'n harde werklikheid.</p> <p>2.7.7.4 Ter verswaring van die gebrek aan geestelike bediening, is baie ouderlinge ongeletterd en kan lidmate nie vanuit die Bybel bedien word nie.</p> <p>2.7.7.5 In die stede is die gebrek aangesettelike versorging ook in die spervuur. In die meeste nuuttoegevoegde gemeentes vind weinig tot geen groei plaas. Dit, terwyl daar miljoene mense in die stede is om te bedien.</p> <p>2.7.8 Die GKSA het 'n nypende tekort aan bedienaars van die Woord, evangeliste en helpers. Daar is 'n ernstige behoefte aan vinniger, meer bekostigbare in-diens-opleiding met kwalifikasies wat as voldoende en as gesagvol aanvaar kan word. Die behoefte bestaan by die bestaande gemeentes en veral by die nuuttoegevoegde gemeentes.</p> <p>2.7.9 Die GKSA beleef 'n verdeling wat sigbaar is in die afwesigheid in mekaar se omstandighede en nood. Die GKSA-huisgenote van die geloof (Gal 6:10) toon gebrek in dienende ondersteuning.</p> <p>2.7.10 Die gebrek aan eenheid benadeel geloofwaardigheid van broederskap in Christus. Gebrek aan eenheid benadeel die kerk se geloofwaardigheid in die oë van die wêreld. Kerkgroei-bediening kan nie aangespreek word vanuit 'n huis wat onderling verdeel is nie (Matt 12:25).</p> <p>Bogenoemde gebreke binne die GKSA kan deur die volgende aanbevelings aangespreek word.</p> <p>3. Aanbevelings</p> <p>3.1 Die erns van die stand van sake binne die GKSA vereis die daarstel van 'n <i>stuurspan</i>. Besondere vaardighede sal</p>	<p>2.7.7.2 Distances, especially in rural areas, cause lack of visitation, thus leading to lack of spiritual pastoring.</p> <p>2.7.7.3 The hard reality of poverty causing the option of transport not even to be considered, leads to lack of proper pastoring.</p> <p>2.7.7.4 Illiteracy of local elders intensify the lack of effective Scriptural pastoring.</p> <p>2.7.7.5 In the cities the newly included congregations also experience shortages regarding spiritual ministry. The tendency is that little to no growth takes place, although there are millions of people to minister.</p> <p>2.7.8 The GKSA portrays an intense shortage of ministers, evangelists and helpers. There is a serious need for faster, more affordable in-service training resulting in qualifications achieved which are sufficient and accepted as authoritative. This need is noticed within both groups in the GKSA, but in a much more intense way amongst the newly included congregations.</p> <p>2.7.9 The GKSA experience a visible division. This division is noted seeing that each group is absent from the other group's circumstances and needs. The GKSA household of faith (Gal 6:10) lacks in serving and supporting one another.</p> <p>2.7.10 The lack of unity negatively works against the supposed integrity of the brotherhood in Christ. Lack of unity negatively works against the integrity of the church as noted by the world. Churchgrowth can not be discussed when the household is divided (Matt 12:25).</p> <p>Above mentioned shortcomings within the GKSA can be addressed by the following recommendations.</p> <p>3. Recommendation</p> <p>3.1 The serious state of the GKSA demands a team championing this challenge. Specific skills will be of great help:</p>
