Request for advice by Regional Synod Randvaal</p> <p>2.1 A Report by the Deputies for Appeal of Regional Synod Randvaal was tabled to Regional Synod Randvaal 2022 regarding an Appeal of GK Krugersdorp against a decision of Classis Wesrand (2021-03-13).</p> <p>2.2 Regional Synod Randvaal 2022 made the following decision about this Report: <i>Referred to the Deputies for Appeal of the General Synod.</i> <i>Motivation: After review of this Report of the Deputies for Appeal and hearing the rebuttal of the appellant and the defendant, a vote had to be cast once all the relevant parties had left the venue. There were only five (5) delegates who were not compromised in any way by the appeal. The Regional Synod concluded that it is not desirable to judge a matter with only five (5) delegates and so it was decided to refer the appeal to the deputies of the General Synod.</i></p> <p>2.3 The Deputies for Appeal (General Synod) reviewed this referral on 10 January 2023 and came to the following judgement:</p> <p>2.3.1 Regional Synod Randvaal requested, in accordance with CO, art 30, advice from the General Synod regarding the review</p>
