Die volgende word aan die Ledevergadering voorgehou vir kennisname en/of besluitneming</p> <p>1.1 <u>Ramingsverligting</u> Rente op agterstallige ramings af te skryf, in onderhandeling met kerke om ooreenkoms te bereik met die invordering van agterstallige ramings.</p> <p>1.2 <u>Ramingsvasstelling</u></p> <p>1.2.1 Die basis vir ramingsvasstelling is die aantal belydende lidmate per gemeente.</p> <p>1.2.2 Die Admin Buro het op versoek van lede, by wyse van ‘n navraag aan gemeentes die inkomste gebaseerde ramingsvasstelling as alternatiewe basis ondersoek. Slegs enkele gemeentes het gereageer, waarvan sommige aangedui het dat hul nie bereid sou wees om jaarlikse geouditeerde finansiële state aan die Admin Buro te voorsien nie. Sonder bogenoemde inligting sal ramingsvasstelling gebaseer op gemeentes se inkomste nie uitvoerbaar wees nie.</p> <p>1.2.3 Ramings is in samewerking met Deputate/Trustees vasgestel, gegrond op die betrokke begrotings en projeksies wat in aggeneem is (waar van toepassing).</p> <p>1.3 <u>Ramingsaanpassings</u> Ramingsaanpassings is tot die absolute minimum beperk. In sommige gevalle is reserwefondse deur Deputate aangewend ten einde hul Sinode opdragte uit te voer.</p>	<p>1. The following is presented to the member meeting for information and/or decision making</p> <p>1.1 <u>“Ramings” Relief</u> Writing off of interest on outstanding “ramings” in negotiation with churches to reach agreement on the collection of outstanding “ramings”.</p> <p>1.2 <u>“Ramings” Rate</u></p> <p>1.2.1 The “ramings” amount is set according to the number of confirmed members of each congregation.</p> <p>1.2.2 Upon request of the members, the Admin Bureau has made enquiries with the churches to investigate the option of an income-based “ramings” system. Only a few churches responded, of which some indicated that they would not be willing to submit their audited annual financial statements to the Admin Bureau. Without the above information setting the “ramings” according church’s income would not be possible.</p> <p>1.2.3 “Ramings” are set in collaboration with the Deputies/Trustees, taking into account the relevant budgets and projections (where applicable).</p> <p>1.3 <u>“Ramings” Adjustments</u> Adjustments were kept to the absolute minimum. In some cases the Deputies used the reserve fund to execute their synod instructions.</p>

Die meeste gemeentes ervaar soortgelyke probleme in 'n meerdere of mindere mate soos byvoorbeeld, nie-bydraende lidmate, werklose lidmate, en 'n styging in die gemiddelde ouderdom van lidmate – wat 'n al groter proporsie afgetrede en bejaarde lidmate tot gevolg het. Die gekonsolideerde begroting word jaarlikse tydens die Mei/Junie Bestuursvergadering deur die Admin Buro bestuur goedgekeur. Die Admin Buro bestuur die fondse in samewerking met die Deputate / Kuratore ooreenkomstig die goed-gekeurde begroting aan die hand van tussentydse bestuurstate.</p> <p>Besluit: Punte 1.1 tot 1.7 kennis geneem.</p>	<p>1.4 <u>“Ramings” Collection</u> The collection of “ramings” range between 85% to 90%. Collection Regulations</p> <ul style="list-style-type: none"> - Monthly issuing of account statements - Reporting of outstanding “ramings” to Classis meetings - Letters of demand to churches - Discussions with churches in arrear <p>1.5 <u>Member Numbers</u> Die number of confirmed members decline each year with approximately 3%. Aside from rising costs, the decline in member numbers places added pressure on “ramings”.</p> <p>1.6 <u>Member Statistics</u> It has come to the attention of Management that some churches adjust the confirmed member numbers, according to which “ramings” are levied, to for example only reflect contributing members. Most of the churches face similar problems to a greater or lesser degree, for example, non-contributing members, unemployed members and the rise in the average age of members – which results in an ever-greater ratio of retired and elderly members. Such adjustment of member statistics simply results in an increase in Rands per member “ramings” and is also to the detriment of churches that provide accurate statistics.</p> <p>1.7 <u>Budget</u> Budgets are drafted annually in collaboration with the different Deputies/Curators. Where Deputies have not met the deadline, Management has budgeted on their behalf. The consolidated budget is approved by the Admin Bureau at the annual May/June Management meeting. The Admin Bureau manages the funds in collaboration with the Deputies/Curators, according to the approved budget in reference to interim management statements.</p> <p>Decision: Points 1.1 to 1.7 noted.</p>

Die personeel se Diensvoorwaardes is dienooëenkomsstig gewysig.</p> <p>Besluit: Punte 1.9 tot 1.11.2 kennis geneem.</p> <p>1.12 <u>Inter-deputaatgroep aanwending van fondse</u> Bepaalde Deputate ervaar erge finansiële druk wat die uitvoer van hul Sinode opdragte baie bemoeilik.</p>	<p>1.8 <u>Audit Committee</u> The Audit Committee is constituted according to Rule 12 of the Admin Bureau Regulations. At the yearly Audit Committee meeting the financial statements, auditor's management letters, solvency reports and other relevant information are reviewed. The Audit Committee makes enquiries into the management of the funds. The Audit Committee then submits a report to the Management of the Admin Bureau/Trustees. There are no specific items that need to be reported to the Synod.</p> <p><u>Recommendation:</u> That the member meeting extend the service term of the current 2 non-management Audit Committee members or appoint new members.</p> <p>Decision: Current members of the Audit Committee's tenure is extended.</p> <p>1.9 <u>Surplus Funds</u> In accordance to the regulations of the Admin Bureau, surplus funds were invested in a way that limits risk and ensures cash flow for the financing of activities.</p> <p>1.10 <u>Special Stipulations</u> None of the non-executive management members of the Admin Bureau received any compensation, except for travel expenses in the execution of the Admin Bureau's instructions.</p> <p>1.11 <u>Post-service medical benefits</u> 1.11.1 The post-service medical benefits of a former staff member was redeemed during 2021, after negotiations. 1.11.2 The post-service medical benefits of 3 staff members were terminated after negotiation. Their conditions of services were amended accordingly.</p> <p>Decision: Points 1.9 to 1.11.2 noted.</p> <p>1.12 <u>Inter-deputy group spending of funds</u> Certain Deputies are under great financial pressure that makes executing Synod instructions difficult.</p>

Modus operandi The Commission approached brs HJD Coetzee and LJ Kruger to form part of the Commission, so that the true income and expenditure of various funds could be checked. Decision: Noted.</p> <p>3. Reasoning Due to the particular needs of the student aid fund and the financial condition of the studentekas, the Commission reasoned that the compulsory collections of the studentekas could be reduced from 6 to 4, so that there could then be two compulsory collections for the student relief fund. The voluntary collections to the ministry in London were taken away and replaced with a voluntary collection for a Licensee relief fund. The balance of the Theological Library and Theological Publications is sound, and therefore the voluntary collections for this purpose have been taken away.
