Sake waarvan die Sinode kennis neem</b></p> <p>2.1 Vir die stand van die Sustentasiefonds word u verwys na die finansiële state van die Administratiewe Buro.</p> <p>2.2 <i>Aansoeke</i></p> <p>2.2.1 Ten spyte van herhaalde versoeke en van die verduidelikende notas, was sekere kerke se aansoeke nie volledig nie en het dit nie aan al die vereistes van die Reglement voldoen nie. Daar was ook aansoeke van kerke wat keurig en netjies versorg was met al die nodige inligting en verduidelikings. Sommige Klassisse het baie deeglike werk gedoen, terwyl ander hulle verantwoordelikheid om die aansoek te motiveer, nagelaat het.</p> <p>2.2.2 Aansoeke is op dieselfde wyse as in die verlede behandel en beoordeel volgens die Reglement. Kerke wat aansoek doen om sustentasie, is gevra vir 'n bedieningsplan sodat die wyse waarop die kerk sy roeping wil nakom, duidelik is.</p> <p>2.2.3 Die kollektes wat gedurende 2019 tot 2022 ingesamel is, kom egter nog nie by die riglyn van R30 per lidmaat pj nie.</p> <p><b>Besluit: Punte 2.1 tot 2.2.3 kennis geneem.</b></p> <p><b>3. Matters that the Synod takes note of</b></p> <p>2.1 See financial statements of the Administrative Bureau for the status of the Sustentation fund.</p> <p>2.2 <i>Applications</i></p> <p>2.2.1 Despite repeated requests and the explanatory notes, certain churches' applications were still not complete and did not meet all the requirements of the procedural rules. There were also applications that were neat and well-presented, containing all the necessary information and clarifications. Some Classes were very thorough, while others neglected to motivate their application.</p> <p>2.2.2 Applications were reviewed as always and assessed against the procedural rules. Churches applying for sustentation were requested to provide a ministry plan in explanation of how the church aims to fulfil its calling.</p> <p>2.2.3 The collections of 2019 until 2022 still, however, fell short of the guideline of R30 per member per year.</p> <p><b>Decision: Points 2.1 to 2.2.3 noted.</b></p> <p><b>3. <p><b>Besluit: Kennis geneem.</b>  <b>3.2 Aanbevelings</b>  3.2.1 Die Sinode neem kennis van die toekennings wat gemaak is en keur die optrede van die Deputate goed.  3.2.2 Die Sinode benoem weer Deputate volgens die Reglement om die volgende opdrag uit te voer: Om volgens die Reglement van die GKSA Sustentasiel-fonds toeseggings te maak uit die beskikbare fondse.  3.2.3 Dat daar jaarliks gerapporteer word aan Klassisse, Streeksinodes en ook aan die Algemene Sinode oor die wyse waarop die sustentasiel toegeken word.  3.2.4 Die Sinode gee opdrag aan die te benoeme Deputate om voort te gaan met fondsinsameling vir die Sustentasiel-fonds deur vrywillige bydraes te vra by kerke en/of instansies en/of persone.  3.2.5 Die Sinode keur 5 kollekte per jaar goed vir die Sustentasiel-fonds met as riglyn R35.00 per lidmaat per jaar.  3.2.6 Die Sinode versoek Klassisse om kerke aan te moedig om toesig te hou (oa deur visitasie) dat die goedgekeurde kollekte opgeneem word.</p> <p><b>Besluit: Punte 3.2.1 tot 3.2.6 goedgekeur.</b></p>		<p><b>Decision: Noted.</b>  <b>3.2 Recommendations</b>  3.2.1 The Synod is to take note of the awards made and approve the actions taken by the Deputies.  3.2.2 The Synod is to again appoint Deputies, in accordance to the Procedural rules, to execute the following instruction: Make awards, in accordance to the Procedural rules, from the funds available in the GKSA Sustentation fund.  3.2.3 The awarding of funds is to be reported to Classes, Regional Synods and also the Regional Synod on an annual basis.  3.2.4 The Synod is to instruct the to be appointed Deputies to continue fundraising for the Sustentation fund, by seeking voluntary contributions from churches and/or institutions and/or individuals.  3.2.5 The Synod is to approve 5 collections per year for the Sustentation fund, setting a guideline of R35.00 per member per year.  3.2.6 The Synod is to request the Classes to encourage churches to ensure (by <i>inter alia</i> visitation) to take up the approved collections.</p> <p><b>Decision: Points 3.2.1 to 3.2.6 approved.</b></p>
