Opdrag (Acta 2003:146, 2.2)</p> <p>1.1 Die Deputate beheer alle diakonale inrigtings van die GKSA in samewerking met die plaaslike kerk in wie se ressort die bepaalde inrigting sorteer.</p> <p>1.2 Om ten opsigte van diakonale inrigtings koördinerend op te tree, met die kerkverband te skakel, geldelike hulp te bied, die administrasie en organisasie deur 'n Skakeldeputaat te reël, ingesamelde gelde vir die inrigtings te administreer.</p> <p>1.3 Om as verteenwoordigers van die kerkverband alle eiendomme wat kragtens sy opdrag verkry is, te beheer en in die regte belang daarvan op te tree.</p> <p>1.4 Om pro-aktief op te tree deur skakeling en koördinerende van alle diakonale werksaamhede van die Gereformeerde Kerke.</p> <p>1.5 Om te skakel met die owerheid en ander barmhartigheid- en liefdadigheidsinrigting volgens KO, art 26.</p>	<p>1. Mandate (Acta 2003:146, 2.2)</p> <p>1.1 The Deputies is to manage all the diaconal bodies of the GKSA in cooperation with the local church where the relevant institution operates.</p> <p>1.2 This includes duties such as: coordination, communicating with the denomination, offering financial aid, arranging for administration and organisation via a contact deputy, administering monies.</p> <p>1.3 As representatives of the denomination, they manage all property accrued for the denomination's task in the best interest of the denomination.</p> <p>1.4 They are to pro-actively coordinate and integrate all diaconal activities of the GKSA.</p> <p>1.5 They must liaise with the authorities and other charitable institutions, in accordance with CO, Art. 26.</p>

Sake waarvan die Sinode kennis neem</p> <p>2.1 <i>Beheer: Diakonale inrigtings</i></p> <p>2.1.1 Daar is 'n diskrepansie tussen die opdrag soos uiteengesit in punt 1.1 en die konstitusie van die Kinderhuise (Acta 2012:102, 1).</p> <p>2.1.2 Dit word voorgestel dat die opdrag soos uiteengesit is in 1.1 gewysig word sodat dit ooreenstem met die konstitusie van die kinderhuise nl: "Die Deputate beheer alle diakonale inrigtings van die GKSA". Dit is ook hoe dit in die praktyk geskied.</p> <p>2.1.3 Beheer oor die inrigtings is deurlopend uitgevoer deur voortdurende</p>	<p>2. Matters that the Synod takes note of</p> <p>2.1 <i>Management: Diaconal Institutions</i></p> <p>2.1.1 There is a discrepancy between the instruction as set out in point 1.1 and the constitutions of the children's homes (Acta 2012:102, 1).</p> <p>2.1.2 It is suggested that the instruction set out in 1.1 be amended to correspond with the constitution of the children's homes, namely: "The Deputies manage all diaconal institutions of the GKSA." This is also how it occurs in practice.</p> <p>2.1.3 Management of the institutions occur continuously by means of regular</p>

<p>2.2.1.1 Die Deputate het voortdurend met die diakonale inrigtings gekommunikeer om behoeftes te bepaal en moontlike onenigheid tussen inrigtings op te los en werkbare oplossings te vind.</p>	<p>2.2.1.1 The Deputies communicated regularly with all the diaconal institutions to determine needs and to resolve any division between institutions and find practical solutions.</p>
<p>2.2.2 <u>Skakeling met kerkverband</u></p>	<p>2.2.2 <u>Communication with the churches</u></p>
<p>2.2.2.1 'n Leemte in skakeling met die kerkverband ten opsigte van diakonale inrigtings is geïdentifiseer. Dit is die voorneme van die Deputate om hierdie leemte in die volgende termyn aan te spreek en te verseker dat die kerkverband ingelig bly ten opsigte van behoeftes, vreugdes en hartseer by die onderskeie inrigtings.</p>	<p>2.2.2.1 A lack of communication with the churches over the diaconal institutions was identified. The Deputies intend to address this shortcoming during the next term and ensure that the churches stay informed of the needs, joys and sorrows of the different institutions.</p>

<p>2.2.3.2 Dit is die Deputate se oogmerk om, deur middel van winste wat gemaak word vanuit die bedrywighede by Glenzicht Aftree-oord, geldelike hulp aan die diakonale inrigtings te kan bied, afgesien van kollekte en donasies wat uit die kerkverband en ander oorde ontvang word. Geldelike hulp is dus afhanklik van wins gegeneer deur Glenzicht aftree-oord.</p>	<p>2.2.3.2 The Deputies aim to offer financial aid to diaconal institutions by means of the profits gained from the operations of the Glenzicht Retirement Home, aside from collections and donations received from the churches and elsewhere. Monetary aid is therefore dependent on profits generated by the Glenzicht Retirement Home.</p>
<p>2.2.3.3 Dit was aan die einde van die 2020 boekjaar moontlik om geld aan die voorsorgfonds toe te deel waaruit die diakonale inrigtings kapitale verbetering kon aanbring. Daar was ongelukkig geen wins aan die einde van die 2021 boekjaar om toe te deel nie. Die Deputate is nog die 2022 geouditeerde state afwagting om te sien of daar na hierdie boekjaar 'n toedeling gemaak kan word.</p>	<p>2.2.3.3 It was possible at the end of the 2020 fiscal year to allocate monies to the provident fund from which the diaconal institutions could make capital improvements. There were, unfortunately, no profits at the end of the 2021 fiscal year to allocate. The Deputies is still awaiting the 2022 audited statements to determine whether any monies can be allocated after this fiscal year.</p>

Die Deputate wil hom bedank vir die werk wat hy oor byna twee dekades gedoen het.</p> <p>2.2.4.2 Sr Anri Kotzee het op 1 November 2021 as die nuwe Skakeldeputaat met haar werksaamhede begin. Ons bid haar die seën van die Here toe op die dienswerk wat sy in hierdie verband gaan verrig.</p> <p>2.2.5 <u>Administrasie van ingesamelde fondse vir diakonale inrigtings</u></p> <p>2.2.5.1 Alle fondse wat in die Deputate se bankrekening ontvang word vir die diakonale inrigtings word in oorleg met die Administratiewe Buro namens die inrigtings geadministreer en op 'n maandelikse basis tussen die inrigtings verdeel. Sou die fondse wat ontvang word vir 'n spesifieke inrigting geormerk wees, word die fondse dienooreenkomstig aan die inrigting oorbetal. Enige ander fondse word 50/50 tussen die inrigtings verdeel.</p> <p>2.3 <i>Eiendomme</i></p> <p>2.3.1 Die SDDS Maatskappy is geïnkorporeer as 'n Maatskappy Sonder Winsbejag en sonder lede of aandeelhouders soos gedefinieer in die Maatskappywet 2008.</p> <p>2.3.2 Alle eiendomme is geregistreer in die naam van die SDDS Maatskappy en word dienooreenkomstig beheer. Eiendomme sluit onder andere die geboue van die diakonale inrigtings en Glenzicht aftree oord in.</p> <p>2.4 <i>Skakeling na binne</i></p> <p>2.4.1 In die afgelope termyn het die Deputate deur middel van die Skakeldeputaat per e-pos en telefonies met diakonieë en Kerkrade gekommunikeer oor verskeie sake. Die Deputate kan getuig dat daar wisselende reaksie op skrywes is. Aan die een kant wil dit voorkom of briewe somtyds nie die nodige aandag geniet nie. Aan die ander kant is daar oorweldigend steun ten opsigte van sommige briewe. Dit wil dus voorkom of dit vir diakonieë en lidmate ook gaan oor die meriete van 'n saak.</p> <p>2.4.1.1 Koördinerings het hoofsaaklik geskied ter ondersteuning van fondsinsamelings vir Noodtoestande. Daar was egter twee</p>	<p>The Deputies would like to express thanks for the work he did over almost two decades.</p> <p>2.2.4.2 Sr Anri Kotzee took over on 1 November 2021. We pray for the Lord's blessing in all endeavours in this regard.</p> <p>2.2.5 <u>Administration of collected funds for diaconal institutions</u></p> <p>2.2.5.1 All funds deposited into the Deputies bank account for diaconal institutions are administered in consultation with the Administrative Bureau on behalf of the institutions and divided among the institutions on a monthly basis. Should the funds received be earmarked for specific institutions, the funds are transferred to the relevant institution. Any other funds are equally divided between the institutions.</p> <p>2.3 <i>Properties</i></p> <p>2.3.1 The SDDS Company is incorporated as a non-profit company without members or shareholders, as defined in the Companies' Act of 2008.</p> <p>2.3.2 All property is registered in the name of the SDDS Company and are managed accordingly. Such property includes <i>inter alia</i> the buildings of the diaconal institutions and Glenzicht Retirement Home.</p> <p>2.4 <i>Internal communication</i></p> <p>2.4.1 Over the past term the Deputies communicated via the Liaison deputy by means of email and telephone with the diaconates and church councils about a range of matters. The Deputies report varying responses to letters. On the other hand, there has also been overwhelming support with some letters. It would thus seem that it's about the merit of a matter for diaconates and members.</p> <p>2.4.1.1 Coordination mainly occurred in terms of support for fundraising for emergencies. As a rule, direct contact was made with diaconates, with the exception of two cases where the</p>

Further information about this is provided in Report 5.</p> <p>2.4.1.2 As mentioned in the 2018 report of the Deputies, diaconal conferences are no longer held for a number of reasons – mainly financial.</p> <p>2.4.1.3 In November 2021 diaconates in the Pretoria area took the initiative to arrange a meeting to discuss the challenges and needs of diaconates. The SDDS was also invited to this meeting and the wish for the return of diaconal conferences of the past was expressed. It will be considered, perhaps on classis or regional synod level rather than national.</p> <p>2.4.1.4 The Deputies Diaconal Affairs created the Facebook page, Curantis, as additional communication and marketing channel.</p> <p>2.5 <i>External communication</i></p> <p>2.5.1 Contact with the authorities: The diaconal institutions contacted, when necessary, the Provincial Departments of Welfare.</p> <p>Decision: Points 2.1 to 2.5.1 noted.</p> <p>3.
