<b>1. Sake waarvan die Sinode kennis neem</b>	<b>1. Matters that the Synod takes note of</b>
1.1 Sedert November 2021 is daar heelwat skuiwe gemaak by Glenzicht Aftree-Oord. Na 5 jaar is daar 'n nuwe span wat die Deputate Diakonale Sake se belange by Glenzicht Aftree-Oord bestuur en die wyse waarop die sake nou hanteer word het drasties verander.	1.1 Since November 2021 there have been a number of changes at Glenzicht Retirement Home. After 5 years a new team took over the management of the interests of the Deputies Diaconal Affairs at Glenzicht Retirement Home and such management has changed drastically.
1.2 Hierdie skuiwe blyk om baie belowend te wees en dat die bate tans optimaal in die belang van die SDDS maatskappy en dienoreenkomsdig in die belang van die Deputate Diakonale Sake se belang bestuur word.	1.2 These changes seem really promising and that this asset will be managed to the greatest benefit of the SDDS Company and in the interest of the Deputies Diaconal Affairs.
1.3 'n Beduidende wins word geprojekteer vir die volgende finansiële jaar. Marktoestande, ekonomie en beskikbare eiendomme om te verkoop speel wel 'n deurslag-gewende rol in die bereiking van hierdie doelwit.	1.3 Significant profit is projected for the next fiscal year. Market conditions, the economy and properties available for sale do however play a huge role in reaching this goal.
1.4 Alternatiewe gebruike vir die spasie van die sogenaamde versorgings-eenheid word tans ondersoek aangesien dit weens beperkte spasie nie volhoubaar bestuur kan word nie en ook nie aan departementele vereistes voldoen nie. Die versorgingseenheid is vir die laaste paar jaar glad nie meer operasioneel nie.	1.4 Alternative uses for the so-called care unit are currently being investigated, since the limited space prevents its sustainability and because it does not comply with departmental requirements. The care unit has not been operational for the past number of years.
1.5 Die voorgestelde oplossing is om hierdie spasie te omskep in wooneenhede/woonstelle.	1.5 The suggested solution is to turn this space into dwelling units/apartments.
1.6 Die bovermelde veranderinge skep ook die geleentheid om verdere ondersoek in te stel na fonds-genererende projekte ten bate van die werk wat deur die Deputate Diakonale Sake verrig word.	1.6 The abovementioned changes also create the opportunity to further investigate fundraising projects for the work of the Deputies Diaconal Affairs.
1.7 Die fokus val daarop om Glenzicht Aftree-Oord op so 'n manier te bestuur dat diakonale inrigtings en ander diakonale werk waarmee die Deputate	1.7 The aim is to manage Glenzicht Retirement Home in such a way that it may in the long term financially support diaconal institutions and other diaconal work of the Deputies Diaconal Affairs.
