This aid must give preference to applications in which such aid can increase the applicant's ability to take care of themselves.</p> <p>1.2 Investigate emergency conditions within and outside the Republic of South Africa. Obtain information over the need of fellow believers within and outside of the GKSA and also others (Gal. 6:10).</p> <p>1.3 Make and maintain contact with other church institutions, bodies and institutions involved in similar support services.</p> <p>1.4 Communicate information and advice over the relevant support provided to the churches.</p> <p>1.5 Bring all need to the attention of the churches and diaconates and request contributions to the Emergency Fund.</p> <p>1.6 Ensure, as far as possible, that the distribution of support occur according to the stipulations of the office of deacon.</p> <p>1.7 Find ways and means to explain their work to the churches through the General Synod.</p>

### **1. Sinodale magtiging**

### **3. Matters that the Synod decides on Recommendation**

3.1 *The Mandate in Point 1 is to be revised as follows:*

3.1.1 Offer, in cooperation with local diaconates, real aid to all people in need due to extraordinary circumstances and who need urgent assistance to provide in their basic needs.

3.1.2 Investigate emergency conditions within and outside the Republic of South Africa. Obtain information over the need of fellow believers within and outside of the GKSA and also others (Gal. 6:10).

3.1.3 Make and maintain contact with other church institutions, bodies and institutions involved in similar support services.

3.1.4 Communicate information and advice to the churches over the relevant support provided.

3.1.5 Bring all need to the attention of the churches and diaconates and request contributions to the Emergency Fund.

3.1.6 Ensure, as far as possible, that the distribution of support occur according to the stipulations of the office of deacon.

3.1.7 Keep diaconates informed of support provided on a quarterly basis, if necessary.

3.1.8 The Deputies must report to the Synod on the aid offered to churches and institutions.

3.2 *The Regulations for the Fund for Emergency Conditions are to be approved.*

#### **REGULATIONS OF THE FUND FOR EMERGENCY CONDITIONS OF THE DEPUTIES DIACONAL AFFAIRS**

### **1. Synodal authorisation**

Objective of the fund</b></p> <p>3.1 Offering financial aid and advice to diaconates.</p> <p>3.2 Offering financial aid in emergencies.</p> <p><b>4. Management</b></p> <p>4.1 <i>The Deputies Diaconal Affairs</i></p> <p>4.1.1 The General Synod appoints the Deputies Diaconal Affairs to fulfil the objectives of the fund in the execution of the Synod's instructions, to comply with the requirements of the fund's regulations and make concerted efforts to grow the Emergency Fund.</p> <p>4.1.2 The SDDS Company manages the Emergency Fund to the benefit of the Deputies Diaconal Affairs and GKSA.</p> <p>4.1.3 The SDDS Company reports quarterly to the Deputies Diaconal Affairs.</p> <p>4.2 <i>Composition of the service group for Emergency Conditions:</i></p> <p>4.2.1 The Deputies Diaconal Affairs internally appoints at least 4 experts to attend to the Emergency Fund on behalf of the Deputies Diaconal Affairs.</p> <p>4.2.2 This service group for Emergency Conditions will report to the Deputies Diaconal Affairs on a quarterly basis.</p> <p>4.3 <i>Task of the service group for Emergency Conditions</i></p> <p>4.3.1 Offer, by means of local diaconates or other institutions, financial aid and advice to those</p>

Funds</b></p> <p>5.1 Funds are accrued by means of contributions (including <i>inter alia</i> special collections, voluntary contributions by churches and diaconates, donations) once the need has been communicated to churches/diaconates.</p> <p>5.2 The service group for Emergency Conditions manages the Emergency Fund.</p> <p>5.3 The fiscal year is 1 April to 31 March.</p> <p><b>6. Administration</b></p> <p>6.1 The fund is administered by the Administrative Bureau of the GKSA that manages the fund according to the set financial policy.</p> <p>6.2 The Deputies Diaconal Affairs and SDDS Company receive a quarterly breakdown on the status of the fund.</p> <p><b>7. Request for funds</b></p> <p>7.1 Any deaconate can apply to the contact deputy for aid.</p> <p>7.2 Every application is considered on merit to fulfil the set instruction (Acta 2003:147, 2.2.2.1).</p> <p><b>8. Application of funds</b></p> <p>8.1 The service group for Emergency Conditions spends the funds to relieve urgent need when the local congregation and Classis cannot shoulder the burden alone.</p> <p>8.2 Once the application for aid to a particular diaconate/institution has been processed, the approved funds are paid</p>
