Mandate (Acta 2018:168, 5)</p> <p>1.1 SDDS falls under the board of directors of the SDDS (Art. 21 company) and such fiscal management will occur in consultation with the Admin Bureau, entailing:</p> <p>1.1.1 the formulation of a financial policy, and</p> <p>1.1.2 representation of the Admin Bureau on the board of directors of the SDDS.</p> <p>1.2 The financial statements of the SDDS as well as the financial statements of Glenzicht Homeowners Association must be provided to the management of the Admin Bureau and also to the audit committee of the members meeting on an annual basis.</p> <p>Decision: Points 1.1 and 1.2 noted.</p> <p>2. Matters that the Synod takes note of</p> <p>2.1 <i>Management</i></p> <p>2.1.1 The SDDS Company and both the President Kruger Children's Home Pretoria and the President Kruger Children's Home Reddersburg reported quarterly to the Deputies Diaconal Affairs regarding their finances. Budgets were also tabled for approval at the Deputies Diaconal Affairs yearly budget meetings.</p> <p>2.1.1.1 The instruction to manage financial affairs in consultation with the Admin Bureau could not be fulfilled for a variety of reasons including a discrepancy in decisions made at Synod 2018.</p> <p>2.1.1.2 The Deputies Diaconal Affairs did however reach out to the Management of the Admin Bureau in 2022 to formulate a workable procedure for managing the financial affairs of the Deputies Diaconal Affairs. The procedure agreed with the</p>

Matters that the Synod decides on</p> <p>3.1 <i>Recommendation</i>: The instructions to the Deputies Diaconal Affairs in regard to their fiscal management are to read as follows:</p> <p>3.1.1 The Deputies Diaconal Affairs manage all the diaconal funds of the GKSA including the funds of the President Kruger Children's Home Pretoria, the President Kruger Children's Home Reddersburg and the funds managed with the SDDS Company.</p> <p>3.1.2 The President Kruger Children's Home Pretoria and the President Kruger Children's Home Reddersburg manage their own funds and report to the Deputies Diaconal Affairs on a quarterly basis.</p> <p>3.1.3 The board of directors of the SDDS Company (a non-profit company) manage all other diaconal funds, including <i>inter alia</i> funds for emergency conditions, donations to the respective children's homes, GKSA collections, Glensicht Retirement Home, etc. who in turn report to the Deputies Diaconal Affairs on a quarterly basis.</p> <p>3.1.4 The Deputies Diaconal Affairs will submit a quarterly report for comment to the Admin Bureau, which will include feedback on all the funds managed by the Deputies.</p> <p>3.1.5 The Deputies Diaconal Affairs will convene a yearly audit committee meeting in which the relevant financial year's audited financial statements of the President Kruger Children's Home Pretoria, the</p>
