They have 2 000 missionaries across the world, of which 29 are working in South Africa. This missionary work is coordinated by a Global Mission Society (GMS). They are members of WRF. They have different levels of ecumenical outreach, namely: (1) General, (2) Missional and (3) Companionship.</p> <p>5.2.3 Fruitful discussion occurred over: (1) ecumenical ties and (2) theological training in South Africa.</p> <p>5.2.4 During such discussions it once again</p>
