SARK</b></p> <p>1.1 <i>Opdrag (Acta 2018:314, 1.2)</i></p> <p>1.1.1 Dat die Sinode besluit dat die GKSA aansoek om waarnemerstatus by die SARK doen.</p> <p>1.1.2 Dat die te benoeme Deputate 'n mandaat ontvang om sodanige besluit uit te voer.</p> <p>1.2 <i>Vir kennisname</i></p> <p>1.2.1 Die GKSA was 'n waarnemer by die SARK tussen 2006 en 2009.</p> <p>1.2.2 In 2018 het die Sinode weer die Deputate opdrag gegee om vir waarnemerstatus aansoek te doen. Die bedoeling was om die werksaamhede te probeer vergemaklik, veral ten opsigte van profetiese getuieis in die kerklike samelewing.</p> <p>1.2.3 Gedurende die afgelope termyn is verskeie probeer om kontak te maak met die SARK, spesifiek om gesprek te voer rondom die moontlikheid van waarnemer-status. Hierdie pogings was onsuksesvol.</p> <p>1.2.4 Wat verder die pogings bemoeilik, is dat die SARK steeds op sy webblad aantoon dat die GKSA waarnemerstatus het, al is dit in 2009 tydens 'n persoonlike gesprek tussen van die Deputate en lede van die Bestuur beëindig. Ten einde alle administratiewe en finansiële implikasies uit te klaar, moet eers die vorige lid-maatskap-situasie uitgeklaar word.</p> <p>1.2.5 Intussen het ds PW Kurpershoek wel die Nasionale Konferensie van die SARK in Oktober 2021 bygewoon, asook die Sentrale Komitee se vergadering.</p> <p>1.2.6 Tydens die Nasionale Konferensie was die tema: <i>The Church: An invitation to be life giving water</i>. Vanuit Esegël 47:1-12 is gefokus op die vernuwende en</p>	<p><b>1. SACC</b></p> <p>1.1 <i>Mandate (Acta 2018:314, 1.2)</i></p> <p>1.1.1 That the Synod decides that the GKSA applies for observer status at the SACC.</p> <p>1.1.2 That the to be named Deputies receive a mandate to execute such a decision.</p> <p>1.2 <i>To be noted</i></p> <p>1.2.1 The GKSA had observer status at the SACC between 2006 and 2009.</p> <p>1.2.2 In 2018, the Synod again instructed the Deputies to apply for observer status. The intention was to try to facilitate the work of the deputies, especially with regard to prophetic testimony in the church society.</p> <p>1.2.3 During the past term, several attempts were made to make contact with the SACC, specifically to discuss the possibility of observer member status. These efforts were unsuccessful.</p> <p>1.2.4 What further complicates the efforts is that the SACC still shows on its website that the GKSA has observer status, even though this was terminated in 2009 during a personal conversation between some of the Deputies and members of the Management. In order to clarify all administrative and financial implications, the previous membership situation must first be clarified.</p> <p>1.2.5 Meanwhile, Rev. PW Kurpershoek did attend the National Conference of the SACC in October 2021, as well as the Central Committee's meeting.</p> <p>1.2.6 During the National Conference the theme was: <i>The Church: An invitation to be life giving water</i>. From Ezekiel 47:1-12 the focus was on the renewing and changing</p>

While there is a clear understanding that the church is the Lord's church which is used by Him to do His work, the focus is also strong on social justice.</p> <p>1.2.7 The advantage of the contact within the SACC is the wide range of conversations that can take place, by which the GKSA's ecumenical calling as a prophetic witness about the truth versus the lie can be advanced, as well the working together with other churches towards a common goal.</p> <p><b>Decision: Points 1.1 to 1.2.7 noted.</b></p> <p>1.3 <i>To be decided</i></p> <p>1.3.1 The Deputies to be nominated continue to try to hold discussions with the SACC's administration to clarify the situation around membership.</p> <p>1.3.2 The to be appointed Deputies participate in the activities of the SACC via relevant inputs and testimony.</p> <p><b>Decision: Points 1.3.1 and 1.3.2 approved.</b></p>
