Hierdie lesse het ten doel om die kategeet ruimte te gee om na gelang van behoeftes en omstandighede sekere temas in meer as een les te beklemtoon. Editorial amendments that were brought to the attention of the Deputies by churches received attention. The impact of this will be reflected in the publication of the following workbooks. A library has been set up so that the current manuals can be made available for electronic use. The processing of this material received attention.</p> <p>1.2.2 The assignment to translate manuals into English is continued.</p> <p>1.2.3 More lessons for the high school were supplemented with manuals received from churches and individuals. These lessons aim to give the catechist room to emphasize certain themes in more than one lesson, depending on needs and circumstances. Contributions from the professors of the TSP have been received and planning is progressing for the processing and publication of these. These contributions will also be made available electronically on a platform.</p> <p>1.2.4 The Deputies were able to enter the field of multimedia in the presentation of catechism lessons. Further development of this material takes place together with other Deputy Groups and other stakeholders.</p> <p>1.2.5 The activities of the Christian Education and Youth Deputies were constantly noted. The Articles of the Kruispad (Crossways) can also be made available to Catechists and children.</p> <p>1.2.6 The needs of children from the previous Synod Midlands and Classis Capricorn must be addressed with the help of Deputies who are fluent in these languages. The Deputies therefore systematically pay attention to such processing of the manuals. Publications will also be posted on the newly formed Platform.</p> <p>1.2.7.1 The Deputies worked closely with other churches with the establishment of Glo-Media. The connection with this digital channel has since been stopped and the equipment that was purchased with the help of funds from the Deputies Catechism is kept at the TSP.</p> <p>1.2.8 The manual for catechists with special needs is available on request. The collaboration and expertise of other role players in this field was further explored.</p> <p>1.2.9 A need that has emerged since Synod 2012 is manuals for children with visual impairment. A request was received to translate one manual into Braille and have it printed. The possibility should be investigated further.</p> <p>1.2.10 The guide for parents in which the necessity of covenant teaching, the necessary interaction between the catechist and the parents of the catechists, the needs of catechists in the different life stages and also the methodology of the manuals are detailed, are still available for churches.</p> <p>1.2.11 Letters were sent out with the request to churches and ministers to also make available material that they use.
